9. Brief background, History (antecedents), ~200 words

In April 2012, the writing of a research manual was started with the following goals: a) elucidate the UP Strategic Plan (2011-2017), b) compile information about available research programs and grants, and c) provide guidelines for high-quality research, ethics and intellectual property.

In March 2013, a small volunteer group was tasked to develop materials for the manual and coordinate with potential contributors and editors. The specialized chapters that were initially identified included research climate in UP, benchmarks and strategic plans, scientific method, mentoring, ethics, intellectual

property, procurement and K to 12. Subsequently, it was deemed critical to include personal essays from researchers coming from the different disciplines. In May 2013, the expanded committee was formed with the main task of producing the research manual with a one-year timeline.

To achieve coherence of the specialized chapters and the essays, the contributors were asked to consider using templates in structuring their paper. In the specialized chapters, scholars describe the evolution of research in UP, the factors that explain UP's current status, the initiatives UP has taken to address deficiencies in its research culture and will present, and critically comment on, further initiatives. In the personal essays, distinguished scholars describe their research briefly, then classify the factors that contributed to, or hindered, their success and propose initiatives that they consider will most successfully move UP toward excellence in research.

The staggered arrival of the paper submissions and the other engagements of committee members in part caused delays in the project. In September 2015, the editorial team was reconstituted to work on the final draft. In January 2016, a version 1 was released online.

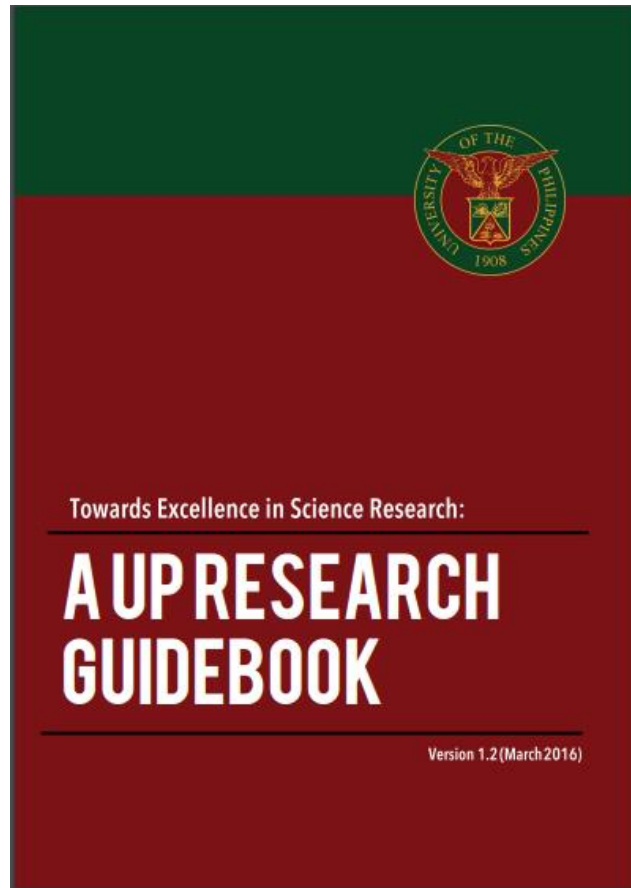
