REQUESTED BOR ACTION: APPROVAL OF REVISIONS ON THE IMPLEMENTING GUIDELINES OF THE UP BALIK-PHD RECRUITMENT PROGRAM

BACKGROUND:

Approved by the UP Board of Regents in its 1275th Meeting on 24 November 2011, the Foreign-trained Filipino PhD Faculty Recruitment Program (Balik PhD Recruitment Program) with implementing guidelines was instituted under the UP Expanded Modernization Program. The BPhD Recruitment Program has been envisioned to directly benefit the units in terms of increased research capacity, enhanced graduate mentoring, and the formation of research groups by recruiting foreign-trained PhD researchers. The BPhD Program is open only to those who have not taught previously in UP.¹


Over the years, OVPAA has experienced various cases in its implementation of the BPhD Program, both with unique and recurring issues. As the Program remains very valuable for the University, our Office believes that it is an opportune time for the guidelines to be updated for the Program to deliver its purpose. The 2011 BOR-approved Implementing Guidelines were reviewed by the OVPAA-constituted Ad Hoc Committee from February to March 2022. The recommendations in the Ad Hoc Committee and the ensuing consultations that were conducted comprise the basis for these proposed revisions.

SITUATIONER:

- For the period 2012-2023, the BPhD program has had a total of 70 recipients, 54 of whom have their projects ended, while 16 recipients have projects that are still ongoing at present. Of the 54 recipients with projects ended, 28 (or 52%) have completed their deliverables in terms of the required publications, while 26 (or 48%) still have incomplete deliverables, to date.
- ELIGIBILITY TO THE PROGRAM: Current guidelines stipulate that the applicant must have a PhD degree
 and several high-quality publications. However, to understand the crucial factors leading to the low
 project completion rates described above, here the ability to complete the project is correlated with
 the postgraduate qualifications.

¹ In contrast to the BPhD program, the general recruitment of PhD holders is open to previous UP faculty members. A separate but related aspect is the need for additional faculty plantilla items. Requesting for items is based mainly on the unit's manpower gap which, in turn, is the difference between fulltime academic personnel and manpower complement needed to deliver the university-approved program offerings. If warranted, plantilla items may be earmarked by the unit for its general recruitment of PhD holders or for the BPhD program application.

• The figure below shows the BPhD project completion rate in relation to the postgraduate qualifications of the recipients. Of the 54 recipients with projects ended, 47 are PhD degree holders only (ie, without postdoc training), while 7 have PhDs and further research training in terms of postdoctoral fellowships. Of the 47 recipients without a postdoc, 21 (or only 45%) have completed the BPhD project deliverables, while 26 (or 55%) still have pending deliverables, to date. On the other hand, of the 7 recipients with postdoc training, all or 100% have completed the required deliverables.



- Furthermore, for those who have completed their projects, on-time submission of deliverables (ie, within the approved project duration) was correlated with postgraduate qualifications. Among those without postdoc training, 33% submitted the required output and reports on time. While among those with postdoc training, 86% have submitted the required output and reports on time. Evidently, hiring PhDs with postdoctoral training guarantees project completion and timely submission of deliverables.
- PROJECT PROPOSAL REVIEW PROCESS: One of the findings of the Program review was the long
 waiting time before the grant application is eventually approved. This was due to the difficulty of
 finding potential reviewers for the project proposals because of the highly specialized nature of the
 research topics. In this regard, the quality of the project proposals may be assured if the proposal is
 co-developed with the host unit, especially in terms of technical feasibility of the project and
 required logistics, assessed at the CU level, before a final review and endorsement by OVPAA for the
 UP President's approval.
- SUPPORT TO SET UP LAB OR STUDIO/ UNIT SHARE: Another recommendation from the Program review was that the host unit must provide a venue and create a nurturing environment for the BPhD faculty. Provided with a venue for laboratory or studio, the BPhD can start doing research right away and be supported by faculty members with related expertise/ interests and research students. To ensure an appropriate venue is provided, funds are needed by the host unit to set up the laboratory or studio. In this regard, the unit must receive a share of the Grant to prepare the facility or studio where the research activities and mentoring will be conducted.
- SUPPORT FOR RESEARCH COLLABORATION: The grant must include funds for collaborations, hosting
 of international experts, and participation in international conferences and networking. The funds
 will help strengthen partnerships with international collaborating institutes, facilitate exchange of
 ideas and best practices, and enable researchers to address complex challenges with global
 significance.

• Based on the recommendations of the Ad hoc Committee that reviewed the BPhD Program, and upon consultation with the Academic Affairs Committee and the Research, Creative Work, and Innovation Committee, including those who have worked in foreign research laboratories, analysis of the data favors recruiting foreign-trained PhDs with postdoctoral training. A prospective Balik-PhD with postdoctoral training, having worked in a research environment for at least 1 year after obtaining PhD, explored related research topics more independently, and with an increased network of collaborators, is deemed more prepared to serve our University for the best. Thus, postdoc training will be included in the eligibility requirements. Furthermore, the correlation between the number of publications and the performance of the BPhD is high, thus, the minimum number of publications for each faculty rank must be also clarified in the revised guidelines.

Under the proposed revised guidelines, the University requires an additional Php30 million over the next three years. This funding is not merely a financial necessity; it represents the University's commitment to bolstering its research capabilities and enhancing its academic reputation. Securing this additional budget will enable the University to attract top-tier candidates, significantly elevating the University's standing in the academic community. With more top-tier BPhD grantees, we will foster groundbreaking research outcomes that can lead to innovative collaborations with industry and open doors to further grant funding.
